It is a single-component, methacrylate-based, solvent-containing, transparent surface protective material.

- Natural stone, concrete, and similar mineral surfaces
- Protection of cement-based mineral surfaces against atmospheric effects

- Due to its quick-drying feature, it quickly gains resistance to atmospheric effects.
- · Resistant to sunlight.

- Reduces water absorption of absorbent surfaces and prevents dirt accumulation on the surface.

Application Procedure:

Surface Preparation:

The surfaces to be applied must be clean, and all oil, dirt, loose parts, cement slurry on concrete surfaces, and other materials that prevent adhesion must be removed.

Application Method:

Before application, the material should be mixed and applied using a brush, short-haired roller, or airless spray gun.

Cleaning of Tools:

Tools should be cleaned with Pomex Thinner.

Points to Consider:

- Application should not be carried out in extreme heat, windy, or rainy conditions, or when the ambient temperature is below +5°C or above +30°C.
- The application surface should be protected from rain for at least 1 hour at +20°C.
- Full curing is achieved in 7 days.
